



SIDELINE SERIES SWEEPSTAKES OFFICIAL RULES

IMPORTANT! PLEASE CAREFULLY READ THESE SWEEPSTAKES RULES (hereinafter, "SWEEPSTAKES Rules") BEFORE ENTERING THE CIRCA SPORTS ILLINOIS SWEEPSTAKES AS THESE RULES AFFECT YOUR LEGAL RIGHTS AND OBLIGATIONS.

NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

Eligibility: The "Circa Sports Illinois Sweepstakes" (hereinafter, the "Sweepstake") is a promotional event that is open only to legal residents of the fifty (50) United States (including District of Columbia), who are at least twenty-one (21) years old at the time of entry, and present at the specified event location of WHERE'S THE DUKE?, INC., d/b/a Joe's Bar located at 940 W. Weed Street, Chicago, Illinois ("Joe's Bar") during the Circa Sports Illinois Sweepstake period. The Sweepstake is subject to all applicable federal, state, and local laws and regulations and is void where prohibited. Participation constitutes entrant's full and unconditional agreement to these Sweepstake Rules, in conjunction with the Sponsor's Terms of Use and Privacy Policy, and Sponsor's decisions, which are final and binding in all matters related to the Sweepstake. Winning the Prize (as defined below) is contingent upon fulfilling all requirements set forth herein. Circa Sports Illinois may also disqualify any customer who is barred, excluded or otherwise not lawfully able to participate, including an individual who is listed on the Statewide Self-Exclusion List or the Illinois Gaming Board's Casino Barred Exclusion List, and such persons shall not be eligible to participate in the Sweepstake or win the Prize. Furthermore, Circa Sports Illinois reserves the right to refuse entry to any person in the Circa Sports Illinois management's sole and absolute discretion.

By entering this Sweepstake, each entrant waives any and all claims of liability against Circa Sports Illinois and its respective parent companies, affiliates, officers, directors, managers, members, employees, and agents, for any and all claims, loss, damage, injury, or death which may occur as a result of entrant's participation in this Sweepstake.

Sponsor: The sponsor of this Sweepstake and gaming licensee is Circa Sports Illinois LLC, located at 1 Fremont St, Las Vegas, NV, 89101 ("Sponsor" or "Circa Sports Illinois").

Timing: This Sweepstake period shall start on Saturday, September 7, 2024, at 12:00 p.m. Central Standard Time (CST) and all entries must be received by the Sponsor by 11:59 p.m. CST on Sunday, February 9, 2025 (hereinafter, the "Sweepstake Period"). This sweepstake will last throughout the entirety of Circa Sports Illinois, "Circa Watch Party Series," held at Joe's Bar located at 940 W. Weed Street, Chicago, Illinois on numerous dates between the September 7, 2024, and February 9, 2025 period. Each and every event date will be accessible to view on-site at Joe's Bar on their on-property digital screens and can also be found on our website under the Joe's Bar, "Circa Watch Party Series" dropdown on www.circasports.com/illinois-app. Customers will be able to make reservations for each individual event date at Joe's Bar found on their website at www.joesbar.com/weedst/sports. The Sponsor shall not be responsible for lost, late, or misdirected entries, server unavailability, computer, any other electronic malfunction, or human error relating to this Sweepstake and/or the use of short-code. All references to time of day refer to Chicago, Illinois, time.

How to Enter: During the Sweepstake Period, customers must attend at least one (1) of the Circa Sports Illinois, Circa Watch Party Series, hosted at Joe's Bar located at 940 W. Weed Street, Chicago, Illinois. Circa Sports Illinois will announce the Circa Watch Party Series with every event date and time prior to the promotional period. Customers will be reminded weekly when Circa Sports Illinois is hosting each watch party held at Joe's Bar. During these respected event dates and times, customers must follow the links and instructions to complete an entry form that will be provided on a QR Code placed on selected tables in Joe's Bar. The designated QR Code will be removed after each Circa Watch Party Series event and replaced upon the start of the next Circa Watch Party Series event. Limit one (1) entry per entrant per event day throughout the Sweepstake Period. Customers are eligible for one (1) additional entry each occasion they are on-site and in attendance for a Circa Watch Party Series at Joe's Bar. The Sponsor will provide each entrant with a confirmation once an eligible entry has been made. By submitting a Sweepstake entry form, an entrant designates themselves as an "Official Entrant" and the only one approved to collect any prize of any kind.

Any attempt by an entrant to obtain more than one (1) entry per entrant per event day, including but not limited to an entrant using multiple email addresses, identities, and/or any other methods, shall void any and all entries by that entrant and could result in disqualification from this Sweepstake and/or disqualification from all future sweepstakes offered by the Sponsor, in the Sponsor's sole discretion. The Sponsor reserves the right to reject any submitted alias for any reason.

Circa Sports Illinois shall not be responsible for any technical difficulties, malfunctions or any other unforeseen issues regarding use of the Circa Sports website. Technical malfunctions to the Circa Sports website shall not change or extend the Sweepstake Period under any circumstances.

Random Drawing: One (1) eligible entrant will be selected as the winner (hereinafter, the "Winner") in a random drawing held within 24 hours after the termination of the Sweepstake Period. Odds of winning depend on the number of valid entries received and the number of Circa Watch Party Series events a customer attends. Remaining valid entries will not carry over to any future sweepstakes or promotions held by the Sponsor.

The Prize: The one (1) selected Winner will receive one (1) Circa Resort & Casino Bunk Suite Package that includes one (1) Stadium Swim® cabana reservation with a \$0 minimum spend on food and beverage and capacity for up to eight (8) persons (\$750.00), two (2) Circa Sportsbook booth morning or evening reservations with a capacity for up to eight (8) persons (\$300.00), and one (1) Bunk Suite reservation that sleeps eight (8) persons (\$900.00) during the midweek day of the Winner's choice (excluding big event days), valued collectively at \$1,950.00 (hereinafter, the "Prize"). Certain restrictions may apply, subject to the availability. Circa Resort & Casino and Circa Sports Illinois shall not be responsible for any liability arising directly or indirectly from the award or use of the Prize. Sports Illinois team where Circa Sports Illinois will then begin to manage all reservations on the Winner's behalf. The Prize may not be transferred and must be accepted as awarded. A winner may not request cash or a substitute prize; however, Circa Sports Illinois reserves the right to substitute the Prize with another prize of equal or greater value if the Prize is not available for any reason, as determined by Sponsor in its sole discretion.

Any disputes concerning the operation of the Sweepstakes and/or the results or prize allocations must be provided to Circa Sports Illinois and Circa Resort & Casino management in writing within such verification

period. At the end of the three (3) day verification period, which includes the winner to provide his/her correct name, address, phone number and government issued picture identification evidencing age eligibility, the Sweepstake results shall be declared official, and payouts will be awarded on February 12, 2025. In the event Circa Sports Illinois is unable to verify the Winner's eligibility, the Prize will be forfeited and will be awarded to an alternate winner randomly selected from among remaining valid entries. In the event of any dispute, Circa Sports Illinois management's decision shall be final.
