



SPORTSBOOK NATIONAL HOCKEY LEAGUE PROMOTION

OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN A PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED BY LAW.

BY ENTERING INTO THIS SWEEPSTAKES, YOU AGREE TO BE BOUND BY THESE OFFICIAL RULES, WHICH CONSTITUTE A CONTRACT, SO READ THEM CAREFULLY. IF YOU DO NOT AGREE WITH THE TERMS AND CONDITIONS OF THIS CONTRACT, DO NOT ENTER THIS SWEEPSTAKES.

Sponsor: The Circa Sports Illinois Sportsbook National Hockey League Promotion (the "Sweepstakes") is sponsored by Circa Sports Illinois LLC, with a principal place of business located at 1 Fremont St, Las Vegas, NV, 89101 ("Sponsor" or "Circa Sports Illinois").

Eligibility: The Sweepstakes is a promotional event that is open to residents of the fifty (50) United States (including District of Columbia), who are at least twenty-one (21) years old at the time of entry and are otherwise eligible to participate in gambling activity in Illinois.

Each person who enters the Sweepstakes is referred to herein as a "Participant". The following persons are not eligible to participate in the Sweepstakes and/or to win a prize: employees, officers, directors, agents, owners of the Sponsor and their respective affiliated entities, any advertising, promotional agency or other entity involved in the creation, administration or fulfillment of this Sweepstakes (collectively referred to herein as the "Sweepstakes Entities"), and the immediate family members (defined as spouse, parent, child, sibling, or grandparent, whether biological, adoptive, step or in-law) and those living in the same household (regardless of whether related).

Patrons who are listed on the Statewide Voluntary Self-Exclusion Program, any other excluded patron list, or are not otherwise eligible to participate in gambling activity in Illinois are not eligible to participate in the Sweepstakes. Patrons who are taking a gaming hiatus / cooling off period through the Circa Sports Illinois mobile app are ineligible for the Sweepstakes until such Patron's exclusion date or cooling off date expires. Participants who are taking a gaming hiatus / cooling off period through the Circa Sports Illinois mobile app are not eligible to participate until after the Participant's exclusion date or cooling off date expires.

Sweepstakes Period: This Sweepstakes will begin on Thursday, November 21, 2024, at 12:00 PM CST and end upon the conclusion of the National Hockey League games that take place on the evening of Saturday, December 21, 2024 (the "Sweepstakes Period").

How to Enter: During the Sweepstakes Period, eligible persons may enter the Sweepstakes by either (1) placing a Qualifying Wager (as defined herein) of \$50.00 or more on any National Hockey League games at one of the three (3) wagering windows at Circa | Sports Illinois Temporary Retail Sportsbook at American Place Casino (the "Sportsbook") and submitting a card consisting of the individual's name, email, and phone number or (2) entering the required information via the online form at <https://www.circasports.com/apc-hockeypromo> (each, an "Online Entry"). Participants are limited to one (1) Online Entry per day.

A qualifying wager is defined as a single wager of \$50 placed on a National Hockey League game. Multiple wagers totaling \$50 on National Hockey League games made on the same day will also qualify for an entry. Any straight wager or parlay that includes a National Hockey League moneyline, puckline, prop, or total qualifies for entry into the Sweepstakes. Circa Sports Illinois Mobile App wagers on the National Hockey League are not valid.

By entering this Sweepstakes, Participant agrees that they have read and accepted (A) these Official Rules; (B) Sponsor's privacy policy, which is available at <https://www.circasports.com/apc-hockeypromo>; (C) Sponsor's Terms of Use, which is available at <https://www.circasports.com/apc-hockeypromo>, and (D) Sponsor's Financial Incentive Notice, where applicable, which is available at <https://www.circasports.com/apc-hockeypromo>, and each of which is incorporated by referenced and made a part of these Official Rules.

Selection of Winners: Within twenty-four hours of the conclusion of the Sweepstakes Period (the "Drawing Date"), one Grand Prize winner will be randomly selected by a representative of Sponsor or its designee (each a "Winner"). Odds of winning depend entirely on the number of valid entries received during the Sweepstakes Period.

Prize(s): One Winner will receive two (2) glass seat tickets to a Chicago Blackhawks Game occurring in the month of January 2025 (excluding the January 18, 2024, game against the Vegas Golden Knights) (the "Grand Prize"). The Grand Prize has an approximate retail value of \$4,000.00

No Prize may be transferred and must be accepted as awarded. A winner may not request cash or a substitute prize; however, Sponsor reserves the right to substitute the Prize with another prize of equal or greater value if the Prize is not available for any reason, as determined by Sponsor in its sole discretion. Tickets subject to availability and all restrictions set forth thereon. Sponsor will choose game date in its sole discretion, with input from Winner.

All costs and expenses associated with a Participant's acceptance, collection and use of a prize not specified herein as being provided as part of the Prize are the sole responsibility of the winning Participant.

Winner will be required to verify eligibility, as applicable, and may be required to complete an "Affidavit of Eligibility" and/or a "Receipt, Release and Discharge" form prior to accepting a Prize and if he/she does not produce such documentation, an alternative winner may be selected and the original winner's rights to the prize may be forfeited, at Sponsor's discretion.

Notification of Winner: Winners will be notified by a representative of Sponsor by Email at the Email provided at the time of entry, within twenty-four (24) hours following the Drawing Date. Each Winner will have 72 hours to verify eligibility, submit any required forms or otherwise collect the Prize, as applicable.

Winner is also responsible for all taxes, costs and expenses not specified herein as being covered by Sponsor including, but not limited to, meals, beverages, gratuities, taxes, hotel incidentals, excursions, fees, surcharges, service charges, transportation expenses, departure and airport taxes, passport fees, visa fees, security fees, and transfers and/or ground transportation including taxis. Winner must comply with all applicable requirements and restrictions related to the prize including, without limitation, applicable travel dates, travel documentation and reservation and confirmation procedures.

LIMITATION OF LIABILITY. By entering the Sweepstakes, and upon receipt of a Prize, each entrant agrees: (a) to be bound by these Official Rules and by all applicable laws and all decisions of

Sponsor; (b) to waive any rights to claim ambiguity with respect to the Official Rules; (c) to waive all of his or her rights to bring any claim, action, or proceeding against any of the Sweepstakes Entities; and (d) to release, indemnify, and hold harmless the Sweepstakes Entities and their respective officers, directors, employees, agents and representatives (each, a "Released Party"), from any liability (including, without limitation, liability for any property loss, damage, personal injury, bodily injury, death, loss, expense, accident, delay, inconvenience or irregularity), costs and expenses (including, without limitation, reasonable outside attorney's fees and costs) that may arise in connection with the Sweepstakes, any receipt, use or misuse of a Prize, or these Official Rules, including but not limited to changes to these Official Rules and/or cancellation of the Sweepstakes.

Further, by entering this Sweepstakes, the Participant is granting Sponsor permission to use his/her contact information to (i) contact him/her regarding a prize, and (ii) provide him/her with marketing or other informational materials related to Sponsor.
