



Circa Sports - Win Derek's Wallet Rules:

The Circa Sports - Win Derek's Wallet Promotion ("Promotion") is a Promotion offered by Circa Hospitality Group I LLC ("Circa Sports").

1. The Circa Sports - Win Derek's Wallet Promotion" (hereinafter the "Promotion") is a physical promotional offering. To be eligible to enter the Promotion in accordance with the terms of these Rules, a patron ("Patron") must be registered and have an account on the Circa Sports app and must also be a legal resident of the fifty (50) United States (including District of Columbia), and at least twenty-one (21) years old at the time of entry. The Promotion is open to new and existing patrons.
2. The Promotional Period will begin at 4:00 AM CT (US Central Time) on February 23, 2026, and will continue until 3:59 AM CT March 16, 2026 (the "Promotional Period") for wagers placed on the Circa Sports app in Missouri during the Promotional Period.
3. To earn a share, a Patron must wager at least \$100 during the Promotional Period. Any patron who wagers at least \$1,000 during the Promotional Period will earn a second share. Any patron who wagers at least \$5,000 during the Promotional Period will earn a third share.
4. Patrons may earn a maximum of 3 shares throughout the Promotion.
5. Wagers must be placed in the State of Missouri.
6. At the conclusion of the Promotion, Circa Sports will distribute \$250,000 ("the Prize Fund") to Circa Sports accounts, divided evenly among the shares earned during the Promotional Period. Patrons will be notified via email that their portion of the Prize Fund has been deposited into the Patron's Wagering Account.
 - a. A Patrons' portion of the Prize Fund will be deposited to the Patron's Wagering Account within 24 hours of the conclusion of the Promotional Period.
7. The value of the Patron's portion of the Prize Fund will be considered cash once in the Patron's Wagering Account, subject to the restrictions in Section 8. Fees for using a Mobile App payment provider may apply and will be the responsibility of the Patron.
8. The value of the Promotional Share cannot be withdrawn, and the full amount must be used to wager on available events within the Circa Sports Mobile App. Proceeds from winning wagers placed using Promotional Share funds may be withdrawn with no restrictions.
9. Employees of Circa Sports or its affiliated companies and employees' immediate family members, are ineligible for the Promotion.
10. Participants must comply with all terms, conditions and rules applicable to the Circa Sports app to be eligible for participation.
11. Management, at their sole discretion, reserves the right to include or exclude any patron from participating in any Circa Sports Promotion for any reason. It is the intent that this Promotion be in compliance with Article III, Section 39(g) of the Missouri State Constitution and the Rules promulgated thereunder. Circa Sports management reserves all rights to modify or cancel this



Promotion at any time without notice. All disputes will be settled by Circa Sports management, and management will be the sole and final judge.

12. Participation in this Promotion by accepting a share(s) of the Prize Fund is the Patron's agreement with and acceptance of the rules for this Promotion.
13. Patrons who are listed on the Statewide Voluntary Self-Exclusion Program, any other excluded patrons list, or are not otherwise eligible to game in Missouri are ineligible for the Promotion.
14. Patrons who are taking a gaming hiatus / cooling off period through the Circa Sports mobile app are ineligible for the Promotion until such Patron's exclusion date or cooling off date expires.
