Circa Sports Kentucky Soccer Ticket Giveaway Promotion Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN A PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED BY LAW.

BY ENTERING INTO THIS SWEEPSTAKES, YOU AGREE TO BE BOUND BY THESE OFFICIAL RULES, WHICH CONSTITUTE A CONTRACT, SO READ THEM CAREFULLY. IF YOU DO NOT AGREE WITH THE TERMS AND CONDITIONS OF THIS CONTRACT, DO NOT ENTER THIS SWEEPSTAKES.

Sponsor: The Circa Sports Kentucky Soccer Ticket Promotion (the "Sweepstakes") is sponsored by Circa Sports Kentucky LLC, with a principal place of business located at 1 Fremont St, Las Vegas, NV, 89101 ("Sponsor" or "Circa Sports Kentucky").

Eligibility: The Sweepstakes is a promotional event that is open to residents of the fifty (50) United States (including District of Columbia), who are at least twenty-one (21) years old at the time of entry and are otherwise eligible to participate in gambling activity in Kentucky.

Each person who enters the Sweepstakes is referred to herein as a ("Participant"). The following persons are not eligible to participate in the Sweepstakes and/or to win a prize: employees, officers, directors, agents, owners of the Sponsor and their respective affiliated entities, any advertising, promotional agency or other entity involved in the creation, administration or fulfillment of this Sweepstakes (collectively referred to herein as the "Sweepstakes Entities"), and the immediate family members (defined as spouse, parent, child, sibling, or grandparent, whether biological, adoptive, step or in-law) and those living in the same household (regardless of whether related).

Patrons who are listed on the Statewide Voluntary Self-Exclusion Program, any other excluded patron list, or are not otherwise eligible to participate in gambling activity in Kentucky are not eligible to participate in the Sweepstakes. Patrons who are taking a gaming hiatus / cooling off period through the Circa Sports Kentucky mobile app are ineligible for the Sweepstakes until such Patron's exclusion date or cooling off date expires. Participants who are taking a gaming hiatus / cooling off period through the Circa Sports Kentucky mobile app are not eligible to participate until after the Participant's exclusion date or cooling off date expires.

Sweepstakes Period: This Sweepstakes will begin on Monday, June 1, 2026, at 10:00 AM CST and conclude on Friday, July 19, 2026, at 11:59 PM CST (the "Sweepstakes Period"). The Sweepstakes will be held at the Circa | Sports Kentucky Retail Sportsbook at The Mint Gaming Hall Kentucky Downs located at 5629 Nashville Rd, Franklin, KY 42134.

How to Enter: During the Sweepstakes Period, eligible persons may enter the Sweepstakes by either (1) placing a Qualifying Wager (as defined herein) of \$50.00 or more on any Major League Soccer game at one (1) of the five (5) wagering windows at Circa | Sports Kentucky Retail Sportsbook at The Mint Gaming Hall Kentucky Downs (the "Sportsbook") and submitting a Patron Information Card consisting of the individual's name, email, and phone number (each, an "Onsite Entry") or (2) entering the required information via the online form at www.circasports.com/events/kentucky-events (each, an "Online Entry"). Participants are limited to one (1) Online Entry during the Promotion. Patrons may place one (1) qualifying wager per day.

A "Qualifying Wager" is defined as a single wager of \$50.00 or more placed on a Major League Soccer game. Any straight wager or parlay that includes a Major League Soccer moneyline, goal line, prop, future, or total qualifies for entry into the Sweepstakes. Circa Sports Kentucky Mobile App wagers on Major League Soccer are not Qualifying Wagers for purposes of the Sweepstakes.

By entering this Sweepstakes, Participant agrees that they have read and accepted (A) these Official Rules; (B) Sponsor's privacy policy, which is available at www.circasports.com/events/kentucky-events; (C) Sponsor's Terms of Use, which is available at www.circasports.com/events/kentucky-events; and (D) Sponsor's Financial Incentive Notice, where applicable, which is available at www.circasports.com/events/kentucky-events; and each of which is incorporated by referenced and made a part of these Official Rules.

Selection of Winners: A total of one (1) winner will be selected at the conclusion of the Promotional Period on July 20, 2026. Within twenty-four hours of the date provided in the Sweepstakes Period (the "Drawing Dates"), one (1) Grand Prize (as defined below) winner will be randomly selected by a representative of Sponsor or its designee (each a "Winner"). Odds of winning depend entirely on the number of valid entries received during the Sweepstakes Period.

Prize(s): One (1) Winner will receive a prize consisting of two (2) Nashville Soccer Club tickets for the August 15, 2026, game versus Inter Miami CF at Geodis Park located at 501 Benton Ave, Nashville, TN 37203 ("Grand Prize"), with an approximate retail value of \$360.00 for the set of tickets.

No Prize may be transferred and must be accepted as awarded. A winner may not request cash or a substitute prize; however, Sponsor reserves the right to substitute the Prize with another prize of equal or greater value if the Prize is not available for any reason, as determined by Sponsor in its sole discretion.

All costs and expenses associated with a Participant's acceptance, collection and use of a prize not specified herein as being provided as part of the Prize are the sole responsibility of the winning Participant.

Winner will be required to verify eligibility, as applicable, and may be required to complete an "Affidavit of Eligibility" and/or a "Receipt, Release and Discharge" form prior to accepting a Prize and if he/she does not produce such documentation, an alternative winner may be selected and the original winner's rights to the prize may be forfeited, at Sponsor's discretion.

Notification of Winner: Winners will be notified by a representative of Sponsor by Email at the Email provided at the time of entry, within twenty-four (24) hours following the Drawing Date. Winner will have 72 hours to verify eligibility, submit any required forms or otherwise collect the Prize, as applicable.

Winner is also responsible for all taxes, costs and expenses not specified herein as being covered by Sponsor including, but not limited to, meals, beverages, gratuities, taxes, hotel incidentals, excursions, fees, surcharges, service charges, transportation expenses, departure and airport taxes, passport fees,

visa fees, security fees, and transfers and/or ground transportation including taxis. Winner must comply with all applicable requirements and restrictions related to the prize including, without limitation, applicable travel dates, travel documentation and reservation and confirmation procedures.

LIMITATION OF LIABILITY.
