Promotional Giveaway Description and Rules

During the Promotional periods listed below, a Circa Sports Kentucky patron who presents a valid ticket to the applicable Summer Concert Series event and places a \$50 wager on any available Circa Sports betting menu item at the Circa | Sports Kentucky Retail Sportsbook at The Mint Gaming Hall Kentucky Downs will receive the opportunity to select and receive either one (1) complimentary \$20 NFL Championship future wager or one (1) complimentary \$20 NCAA Football Championship future wager. The Promotion will take place at the Circa | Sports Kentucky Retail Sportsbook located at The Mint Gaming Hall Kentucky Downs, 5629 Nashville Road, Franklin, Kentucky 42134.

Promotional Periods

First Promotional Period

Friday, July 17, 2026, at 10:00 a.m. CT through Saturday, July 18, 2026, at 6:00 p.m. CT.

Eligible concert: *Journey Tribute Concert* held on July 18, 2026, at The Mint Event Center in Franklin, Kentucky.

Second Promotional Period

Friday, September 18, 2026, at 10:00 a.m. CT through Saturday, September 19, 2026, at 6:00 p.m. CT.

Eligible concert: *John Denver Tribute by Jim Curry* held on September 19, 2026, at The Mint Event Center in Franklin, Kentucky.

Rules:

- Patrons must present a valid ticket for the applicable concert during the applicable Promotional period.
- Patrons must place a wager of \$50 or more to qualify for the Promotion.
- Wagers must be placed over the counter at one (1) of the Sportsbook wagering windows.
- Wagers placed at a Sportsbook kiosk or through the Circa Sports Kentucky mobile app are not eligible for this Promotion.
- Straight wagers and parlay wagers are both eligible for this Promotion.
- Each unique customer is eligible to receive one (1) complimentary future wager during each Promotional period.
- Each customer that places a singular qualifying wager of \$50 or more will receive one (1) complimentary \$20 future wager.



- Eligible patrons may select either:
 - One (1) \$20 NFL Championship future wager; or
 - One (1) \$20 NCAA Football Championship future wager.
- Circa Sports Kentucky reserves the right to add additional complimentary future wagers due to high demand.
- Future wager tickets will be printed and distributed by Sportsbook personnel.
- All ticket numbers may be recorded and maintained for Circa Sports audit, accounting, compliance, and regulatory purposes.
- Circa Sports Kentucky representatives may record the patron's name, contact information, and ticket number upon issuance of a complimentary future wager.
- Complimentary future wagers cannot be exchanged for cash.
- Complimentary future wagers cannot be sold, transferred, assigned, or redeemed for cash value.
- All future wagers will be graded in accordance with Circa Sports Kentucky House Rules.
- All patrons must be at least twenty-one (21) years of age and otherwise eligible to participate in gambling activity in the Commonwealth of Kentucky.
- Employees, officers, directors, agents, owners of Circa Sports Kentucky, their affiliated entities, advertising agencies, Promotional agencies, and entities involved in the administration of this Promotion, together with their immediate family members and household members, are not eligible to participate.
- Patrons who are listed on Circa Sports Kentucky's Self-Exclusion List, the Mint Gaming Hall at Kentucky Downs' Self-Exclusion List, both, or any other excluded patron list, or are not otherwise eligible to participate in gambling activity in Kentucky are not eligible to participate in the Sweepstakes.
- Patrons currently participating in a gaming hiatus or cooling-off period through the Circa Sports Kentucky mobile application are not eligible to participate until such period has expired.
- Circa Sports Kentucky is not responsible for lost or stolen wagers, cash, vouchers, or Promotional tickets. Lost, misplaced, or otherwise unavailable Promotional tickets will not be replaced.
