



America 250 Promotion Rules:

The Circa | Sports™ America 250 Promotion (“Promotion”) is a Promotion offered by Circa Sports Kentucky LLC (“Circa Sports” or “Circa Sports Kentucky”).

1. The Circa | Sports™ America 250 Promotion (hereinafter the “Promotion”) is a promotional offering. To be eligible to participate in the Promotion in accordance with the terms of these Rules, a patron (“Patron”) must be a legal resident of the fifty (50) United States (including District of Columbia), and at least twenty-one (21) years old at the time of entry.
2. The Promotional Period will begin on August 3, 2026, and will continue until either 1,000 Patrons have qualified or September 30, 2026, whichever occurs first. Management may, in its sole discretion, extend the Promotional Period if necessary, in accordance with section 7.
3. The Promotion is open to new and existing Patrons using the Circa Sports Kentucky mobile app in Kentucky. Deposits and Qualifying Wagers must be placed while in the State of Kentucky.
4. Patrons wishing to participate in the Promotion must complete the following steps: (1) fund the Circa Sports Kentucky mobile wagering account with at least \$250 (the “Deposit”); and (2) wager \$250 of the qualifying Deposit (“Qualifying Wager”) subject to the conditions in section 6.
5. Once a Circa Sports employee verifies that a Patron has completed both steps, \$250 will be credited in their Circa Sports Kentucky wagering account within twenty-four (24) hours (“Matched Amount”).
6. **Wagering and Eligibility Restrictions**
 - a. **Qualifying Wagers must have minimum odds of -250. This applies to both straight bets and parlays. Qualifying Wagers must be fully settled to be eligible.**
 - b. **Patrons may not place wagers on both sides of the same event or otherwise structure bets to reduce or eliminate risk (including hedging or matched betting). Any such wagers may be deemed non-qualifying at Circa Sports’ sole discretion.**
 - c. **Collusion strictly prohibited: Coordinating with others (including friends, family, or other account holders) to place opposing or offsetting wagers is not permitted. If Circa Sports suspects coordinated activity, it may void wagers, withhold promotional funds, and disqualify all involved accounts.**



- d. Limit one (1) Patron per household, defined as individuals sharing the same residential address and/or last name. Circa Sports reserves the right to determine eligibility and require verification. Attempts to circumvent this limit may result in disqualification and forfeiture of promotional funds.**
 - e. Eligible Patrons may redeem this offer one time only across all Circa Sports jurisdictions. Patrons who redeem this offer in one state are ineligible to redeem the offer in any other state where Circa Sports operates.**
 - f. Circa Sports reserves the right to review all activity and determine whether wagers meet the intent of the Promotion, and to exclude any Patron at its sole discretion.**
- 7. The Promotion is available only to the first 1000 qualifying Patrons, after which the Promotion will end. Patrons can navigate to <https://www.circasports.com/kentucky-app> to verify if the Promotion is ongoing. Management may, in its sole discretion, extend the Promotional Period beyond the first 1000 Patrons. Any such extensions will be indicated [here](#).
- 8. The value of the Matched Amount cannot be withdrawn, and the full amount must be used to wager on available events within the Circa Sports Kentucky Mobile App subject to the requirements in section 6. Proceeds from winning wagers placed using the Matched Amount funds may be withdrawn with no restrictions. Fees for using a Mobile App payment provider may apply and will be the responsibility of the Patron.
- 9. Matched funds cannot be used to qualify for any future Circa Sports Kentucky promotions.
- 10. Participants must comply with all terms, conditions and rules applicable to the Circa Sports Kentucky mobile app to be eligible for participation.
- 11. Employees (current or past) of Circa Sports or its affiliated companies, immediate family members, or any employee of Circa Hospitality Group I LLC, and its affiliates, are ineligible for the Promotion.
- 12. By participating, a Patron agrees to grant Circa Sports unconditional use of his or her name and likeness/image for use in any promotional material, advertising and/or announcements without compensation, consideration, notice, review or further consent. Circa Sports has sole and absolute discretion to determine the content of any promotional material.
- 13. Management, at their sole discretion, reserves the right to include or exclude any Patron from participating in any Circa Sports Kentucky Promotion for any reason. It is the intent that this Promotion be in compliance with applicable Kentucky state laws and regulations. Circa Sports management



reserves all rights to modify or cancel this Promotion at any time without notice. All disputes will be settled by Circa Sports management, and management will be the sole and final judge.

14. Patrons who are listed on the Statewide Voluntary Self-Exclusion Program, any other excluded patrons list, or are not otherwise eligible to game in Colorado, Iowa, Missouri, Kentucky, and Illinois are ineligible for the Promotion.
15. Patrons who no longer wish to participate in the Promotion should contact support@circasports.com. Patrons who cancel their participation before completing all requirements outlined in Section 4 will not be eligible for a refund. If Matched Funds have already been credited to a Patron's Circa Sports Kentucky mobile wagering account, those funds will be removed upon cancellation of participation.
16. Patrons who are taking a gaming hiatus / cooling off period through the Circa Sports or Circa Sports Kentucky mobile app are ineligible for the Promotion until such Patron's exclusion date or cooling off date expires.
